## How to order a transcript

Transcripts can be ordered two ways: by simply submitting the <u>EX107 Form online</u> or <u>manually downloading</u>, completing and emailing the EX107 Form. Payment is normally required in advance of the transcript being delivered. <u>Learn more</u> about how to order.



#### **Costs for transcript**

Costs are calculated based on the number of folios (72 words) transcribed and the delivery turnaround time requested.

You can easily and conveniently get an indication of the costs via our <u>online</u> <u>estimator</u>.



#### **Turnaround times**

For Crown Court proceedings heard within the South East jurisdiction, there are several turnaround times available. Contact us is your request is more urgent.

- Within 48 hours\*
- Within 3 working days\*
- Within 7 working days\*
- Within 12 working days\*

Please note: Auscript relies on the Court to approve your request for transcript so there is likely to be a lead time while this approval occurs.
